# **Foreword**

2025 was an exceptional year of growth and impact for the Grant Thornton Foundation. It also marked my first year as the Chairperson and I was humbled by the generosity and commitment of our people nationally. It's been a privilege to lead the team through what has been a rewarding year of giving back to our communities.



Our core focus continues to be helping young people through supporting their mental health, enabling inclusion and access to sport for children who have intellectual disabilities, as well as striving for a focus on women's wellbeing through supporting charities who strive to create a safe environment for women fleeing from family and domestic violence.

Throughout this year, our teams have participated in a variety of volunteer activities – from swimming rely races, polar plunges, push up challenges, packing dignity hampers and donating food gift cards, to collecting food, toys and containers for change – fostering purpose and making room to give back to those in need. We have also provided skilled volunteering including training on Excel basics, mock interviews with young people, fraud and corruption awareness training. We also offer pro bono services such as facilitating risk assessment workshops, and facilitating strategic planning workshops.

Through our partnership with RizeUp, we helped provide 75 new beds, mattresses, linen and created safe and nurturing spaces for children and young people rebuilding their lives after domestic and family violence; for headspace, we funded translated multilingual mental health resources for international students, with headspace presenting the project at the National Multicultural Health and Wellbeing Conference 2025; we helped Women's Resilience Centre by taking their Financial Wellbeing Program on the road, visiting 11 regional towns in NSW.

We're also helping Women's Resilience Centre develop a comprehensive suite of four financial wellbeing programs tailored to different stages and needs, facilitated by skilled experts creating trauma-informed learning environments; and we continued supporting Special Olympics Australia through 68 school visits, 98 programs delivered, and 5,061 students engaged.

With 2026 around the corner, we're excited for what the new year will bring. We're thrilled to be continuing our work with Special Olympics Australia, headspace, RizeUp and Women's Resilience Centre. With a strong focus on mental wellbeing for youth and safe housing for victims of family and domestic violence, the Grant Thornton Foundation is committed to continuing to support these charities as they strive to drive a positive difference.

While we support Special Olympics Australia, headspace, RizeUp and Women's Resilience Centre at a national level, throughout the year, each office also participates in local initiatives with our people supporting other charities close to their hearts. It is incredible to see how much our people engage and participate in these causes.

Finally, I'd like to acknowledge the large amount of work that goes into making the Grant Thornton Foundation a success. From setting up volunteer days, to encouraging donations for our initiatives – the team work tirelessly to ensure we deliver on promises with impact. I'd like to extend a heartfelt thank you to Directors, the local Social Responsibility Committees, our volunteers, regular donors, and charity partners – without you, the Grant Thornton Foundation wouldn't drive such positive change.

# About us

The Grant Thornton Foundation was established in 2014 with the objective of consolidating our community support initiatives nationwide. The organisation is financed through workplace giving donations from our employees, in addition to a substantial annual contribution from Grant Thornton Australia Limited (GTAL). This means that for each dollar our people donate, the impact is doubled through GTAL's support.

Through both national and local partnerships, the Foundation maintains an Independent Board that meets every two months to discuss priorities, assess progress against our strategy, and evaluate the impact and funding of our charity partners. Every three years, we conduct a survey with our people to ascertain their preferences for charitable causes, which in turn informs our direction and charity partner selection.

# Our role

The Grant Thornton Foundation helps support local and national charities through raising awareness, hosting events and supporting these initiatives in our Sydney, Melbourne, Brisbane, Adelaide, Cairns and Perth office locations. Employees can participate in workplace giving. Through this program, 50% of the funds are allocated to the local Social Responsibility Committees in each office, while the remaining 50% supports the Foundation's National Charity Partners.

The organisation delivers a Financial Wellbeing Program to provide essential financial literacy skills and education. With a goal to scale in areas where these resources are the scarcest, our funding has allowed the organisation to reach more women.

# headspace

headspace strives to ensure all young people are positively engaged with their mental health and communities. The organisation strives to provide young people with the skills to have and maintain positive mental health and wellbeing.

We continue to fund a program for young international students experiencing the challenges of living in a different culture, often with English as a second language and without their family and social supports. From the positive feedback, this year the team at headspace was able to translate a suite of mental health resources used by multicultural communities across the country.

# Who we work with locally

We also support local charity partners run by our social responsibility teams in each office. In addition to our support at a national level, we participated and held events in each of our offices to give back.

- Helped: With Eat Up by making over 1,000 sandwiches for children attending school without lunch.







# **Notes to the Financial Report**

For the year ended 30 June 2025

# 1 Nature of operations

The Grant Thornton Foundation (the Foundation), is a Public Ancillary Fund, a not-for-profit charitable trust established and domiciled in Australia. The Trustee of the Foundation is Grant Thornton Foundation Pty Ltd (ABN: 95 601 096 753). The Foundation is designed to act as an intermediary between Grant Thornton Australia Limited employees and deductible gift recipients.

The Foundation's main duties include:

- Fundraising process of fundraising from the public for the charitable purpose.
- Administration processes of managing the Foundation to meet its compliance obligations.
- Investment the investment of Foundation assets to protect the value of the fund.
- Donation/grant-making the donation of funds or grant making by the Foundation to eligible entities.
   Donations to deductible gift recipients whose purpose aligns to the Foundation's strategic themes.

# 2 Summary of Material Accounting Policies

### 2.1 Basis of preparation

The financial report is a general purpose financial report which has been prepared in accordance with the requirements of the Trust Deed of the Foundation, the Australian Charities and Not-for-profits Commission Act 2012, the Charitable Fundraising Act 1991, Australian Accounting Standards – Simplified Disclosures and other authoritative pronouncements of the Australian Accounting Standards Board

This financial report has been prepared on an accrual basis of accounting, except for cash flow information, including the historical cost convention and the going concern assumption.

Material accounting policies adopted in the preparation of the financial statements are presented below and have been consistently applied unless otherwise stated.

The financial report was authorised for issue by the Board of Grant Thornton Foundation on 15 October 2025.

# 2.2 Adoption of new and revised accounting standards

No new or amended Australian Accounting Standards and Interpretations that are applicable for the current reporting period have had a material impact on the Foundation's financial statements. The Foundation has also not early adopted any Australian Accounting Standards or Interpretations that are not yet effective. The adoption of new and amended standards and interpretations is not expected to have a material impact on the Foundation's financial statements in future periods.

# 2.3 Revenue

# Revenue recognition policy for revenue from contracts with customers (AASB 15)

AASB 15 requires revenue to be recognised when control of a promised good or service is passed to the customer at an amount which reflects the expected consideration. The customer for these contracts is the fund provider. Revenue is recognised by applying a five-step model as follows:

- 1. Identify the contract with the customer
- 2. Identify the performance obligations
- 3. Determine the transaction price
- 4. Allocate the transaction price to each performance obligation
- 5. Recognise revenue as or when performance obligation satisfied

# 2.3 Revenue (continued)

# Revenue recognition policy for revenue from contracts with customers (AASB 15) (continued)

Revenue is recognised under AASB 15 when the performance obligations in a service arrangement are sufficiently specific to identify satisfaction of those obligations. Under AASB 15 revenue is recognised when performance obligations are satisfied. When amounts of income are received, other than investment income, that are not subject to specific performance obligations, they are generally recognised immediately in profit and loss under AASB 1058 Income of Not-for-profit Entities. Income streams recognised under AASB 15 will include membership fees, event charges, and certain sponsorships that are enforceable and with specific performance obligations.

# Revenue recognition policy for revenue streams which are either not enforceable or do not have sufficiently specific performance obligations (AASB 1058)

During the year, the Foundation did not have any revenue streams which were enforceable under AASB 15. These revenue streams which are not enforceable or for which there are no sufficiently specific performance obligations are brought to account when received in accordance with AASB 1058.

# Donations from Partner and employee giving, Grant Thornton Australia Limited, or other sources

Monetary donations are recognised as revenue when the Foundation gains control of the contribution or the right to receive the contribution.

### 2.4 Income taxes

No provision for income tax has been raised as the Entity is exempt from income tax under Div. 50 of the *Income Tax Assessment Act 1997*.

# 2.5 Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and demand deposits, together with other short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

# 2.6 Funds

# **Accumulated Funds**

The movement in accumulated funds represents the surplus or deficit for the year.

# **Emergency Relief Fund**

The Foundation established this fund with the specific aim of providing relief in emergency situations, including natural disasters in line with the vision and principles of the Foundation. Transfers to and from the fund is determined by the Board and conducted by reference to the revenue of the Foundation and needs of the fund for the year.

# **Allocated Funds**

The allocated funds represent amounts that have been designated for specific charitable purposes.


