Conditions of Entry

- 1. The FBA (State) Hall of Fame is open to Australian Family Businesses.
- 2. Induction recognises advancements and achievements in Family Business.
- 3. A maximum of 3 family businesses will be inducted in each state in each year.
- 4. If the judges consider the nominations received do not meet the criteria, no nominee will be inducted.
- 5. Entries can only be made by the nominee or by another Family Business or by an Adviser.
- 6. Nominations are to be made on this form and submitted with supporting documentation.
- 7. Nominations will be considered on the information provided on the form and accompanying supporting material.
- 8. The completed submission must be lodged in electronic format only, via email.
- 9. To determine the inductees, FBA will select a panel of appropriately qualified and experienced people who will be bound by a code of conduct. FBA may or may not disclose the identities of the panel members.
- 10. The panel will consider nominations received, and may seek external expert advice.
- 11. The panel will make the induction decision. In all cases this will be final and no correspondence will be entered into.
- 12. Nominees are not to have any direct contact with the panel.
- 13. FBA is not liable under any circumstances associated with these inductions for any damage, infringement or violation affecting the property rights of the nominee, an organisation or an individual.
- 14. Nominations and supporting materials will not be returned.
